

CTMS Twitter Competition Rules

Prize

1 of 4 double VIP tickets and a driving experience at the Cape Town Motor Show (CTMS) for either 2 or 3 March 2019 at GrandWest Casino and Entertainment World, Cape Town.

Competition rules

1. The name of the competition is "CTMS Twitter Competition" and Capitec Bank is the promoter of the competition
2. The competition runs from 18 – 25 February 2019 ("competition period")
3. The competition closes on Monday, 25 February 2019 at 12pm
4. The competition is open to natural persons
 - 4.1 who are citizens of, and living in, the Republic of South Africa, and
 - 4.2 who is 18 years and older
 - 4.3 who have their own transport and accommodation to attend the CTMS on either 2 or 3 March 2019 at GrandWest Casino and Entertainment World, Cape Town
 - 4.4 who are not excluded in terms of the competition rules, including but not limited to rule 17 below
5. In order to be eligible for entry into the competition, you need to comply with the above conditions
6. This is a social media competition that will be run on Twitter. To enter, retweet our original competition post during the competition period and follow the official Capitec Twitter account. All valid entries will be collated on 26 February 2019 for entry into a random draw for the double VIP tickets to the 2019 CTMS. There will only be 4 (four) winners who will be randomly selected by a computer programmed algorithm. Only 1 retweet, and therefore only 1 entry, is allowed per person
7. The winners will be contacted through their social media handle
 - 7.1 The winners must respond within 24 hours of the social media contact. After 3 failed attempts to contact the winners, they will forfeit the prize and the second-drawn winner will be contacted
 - 7.2 The winners will be contacted to verify their contact details, identity (including identity number) and any other relevant information to ensure their eligibility. If the winners are not eligible in any way, they will forfeit the prize and the second-drawn winner will be contacted
 - 7.3 Prize includes VIP hospitality tickets for each winner and a partner only
 - 7.4 Prize does not include any transport or accommodation costs
 - 7.5 Prize is not negotiable and cannot be transferred or exchanged for cash
 - 7.6 The winners' details will be sent to CTMS who will allocate the VIP tickets and add the winners' names to the guest list at the entrance of the hospitality area
