

Capitec Live Better Festival Twitter Competition Rules

Prize

How to enter

Simply follow Capitec Bank (@CapitecBankSA) on Twitter and retweet our original competition post during the competition period for entry into a random draw for the VIP tickets to the Capitec Live Better Festival.

1. The name of the competition is "Capitec Live Better Festival Twitter Competition" and Capitec Bank is the promoter of the competition
2. The competition runs from 27 November – 7 December 2018 ("competition period")

 - 4.1. who are citizens of, and living in, the Republic of South Africa, and

 - 4.5 who are not excluded in terms of the competition rules, including but not limited to rule 17 below

6. This is a social media competition that will be run on Twitter. To enter, follow Capitec Bank (@CapitecBankSA) on Twitter and retweet our original competition post during the competition period. All valid entries will be collated on 7 December 2018 for entry into a random draw for the VIP tickets to the Capitec Live Better Festival. There will only be 1 (one) winner who will be randomly selected by a computer-programmed algorithm
7. The winner will be contacted through their social media handle
 - 7.1 The winner is required to respond within 24 hours of the social media contact, or else they forfeit the prize
 - 7.2 The winner will be contacted to verify their contact details, identity (including identity number), that they have a Capitec Bank account in their name and any other relevant information to ensure their eligibility
 - 7.3 If the winner does not have a Capitec Bank account at this time, they will forfeit the prize and the second-drawn winner will be contacted
 - 7.4 Prize includes access to the Capitec Gold Lounge as well as food and beverage but does not include any transport or accommodation costs
