

Go Cashless Challenge and Competition Rules

Prizes

50 cash prizes of R1 000 each and 20 Huawei Mate 20 Pros valued at R14 789 each (SIM card and airtime excluded), will be awarded over a period of 4 weeks.

The weekly lucky draws will take place:

- 8 March 2019: 12 x R1 000 cash, 5 x Huawei Mate 20 Pros
- 15 March 2019: 12 x R1 000 cash, 5 x Huawei Mate 20 Pros
- 22 March 2019: 12 x R1 000 cash, 5 x Huawei Mate 20 Pros
- 1 April 2019: 14 x R1 000 cash, 5 x Huawei Mate 20 Pros

How to enter

To qualify for the weekly draw, you have to perform at least 3 digital transactions in a week during the competition period. For every 3 digital transactions you automatically qualify for one entry.
