

# Capitec Masterpass™ Woolworths campaign

## Instant Prize

A Woolworths gift card valued at R100.

## Lucky draw prize

5 iPhone XS handsets worth R24 249.03 every week until the end of December. This excludes any contract or airtime.

## How to qualify

Capitec clients must use the Capitec Masterpass app to make 5 Capitec debit or credit card purchases between 6 November – 31 December 2018 in order to get a R100 Woolworths gift card. Clients who qualify for a gift card will also get an entry into a lucky draw to stand a chance to win 1 of 5 iPhone XSs every week of the competition.

The minimum spend per Capitec Masterpass app transaction is R30.

## Campaign and competition rules

1. The name of the campaign is "Capitec Masterpass™ Woolworths Campaign"
2. The lucky draw competition for the iPhones runs from 6 November 2018 and closes at 11:59pm on 31 December 2018
3. The Woolworths gift card promotion runs from 6 November 2018 and ends at 11:59pm on 31 December 2018

  - 4.1. Who are citizens of, and living in, the Republic of South Africa, and this campaign is only open to persons over the age of 18 years
  - 4.2. Who registered with the Capitec Masterpass app and performed 5 transactions on the app with a minimum value of R30 each with a Capitec debit or credit card during the campaign date
5. Each person may only receive one R100 Woolworths gift card per month
6. Your contact details will be entered into the competition if you qualify for the gift card (4.2). This will be considered a valid entry into the lucky draw competition prize
7. All valid entries will be collated on a weekly basis for the duration of the competition period for entry into a random draw to stand a chance to win 1 of 40 iPhone XSs (5 every week for 8 weeks). No draw will take place on the week of 18 December 2018, 25 December 2018 and 1 January 2019. The lucky draw for the iPhones for these 3 weeks will take place on 8 January 2019

9. Capitec employees are eligible to qualify for Woolworths gift cards but cannot participate in the lucky draw competition for the iPhone XS handsets
10. iPhone XS winners will be notified with a telephone call and the details on how to collect your prize will be given. This competition will be audited on a weekly basis by an audit firm at the Mastercard® office and verified. Winners must collect their prize from their nearest Capitec branch. A valid ID or driver's licence will be required to collect the prize (iPhone XS)
11. Clients who qualify for the R100 Woolworths gift card will be sent an SMS and a Capitec Masterpass in-app message with virtual gift card details. Gift cards may be used immediately and are valid for 36 months from 6 November 2018. Restricted to 1 x R100 gift card per person per month
12. The virtual gift cards are redeemable on Woolworths online and at any Woolworths store in South Africa, excluding Engen stores and the Woolworths app. Please produce your ID or driver's licence when redeeming your card in-store
